- We build and sustain relationships, which involves caring for the physical, emotional, and spiritual needs of one another.

Following Christ

• We are disciples of Jesus Christ and model our own lives (and faith) after His example and teachings.

In all these things we are connected with the Mennonite denomination and identify with its values and traditions.

Comments were overall very positive regarding this expression of our core values. We met in small groups for specific affirmations and to give suggestions for final wordsmith. Walt Nickeson and Mark Shelly will work on a final draft. This will be distributed along with other agenda items for the June 3 congregational meeting, where we will seek formal approval for this document. Draft Covenant of Understanding

between Sonya Stauffer Kurtz and Rochester Area Mennonite Fellowship, Rochester, NY

As an ordained minister, Sonya pledges

- to cultivate a life of prayer and Bible study

- to serve the church by leading worship and adult education as time and interest allow
- to serve in church ministries as time and interest allow
- to be available to congregational members for conversations regarding faith and spirituality, as time and interest allow
- to maintain an awareness of developments in our conference and denomination, and to serve as a link between the congregation and the broader church, as appropriate
- to take on leadership roles in the conference and denomination as time and interest allow (serving as NYMC moderator until Sept. 2013)
- to officiate at weddings as appropriate
- to uphold ethical standards for leaders as outlined in <u>A Mennonite Polity for Ministerial Leadership</u> (1996, Faith and Life Press, pp 106-127)
- to be accountable to the congregation through the leadership team, and to the conference and denomination through the NYMC leadership commission

As members of Rochester Area Mennonite Fellowship we pledge

- to encourage and support Sonya in her ministry
- to explore with Sonya the ways ordained ministry can enhance the ministry of RAMF
- to continue to exercise our own gifts and ministries with zeal
- to provide accountability and discernment through regular meetings of a group of interested persons, the Minister Congregation Relations Committee
- to review this Covenant and relationship at least annually, typically in May
